Sir,
With reference to your letter dated 11th Feb 2004, I have
the honour to say that by issuing Notification dated 15-05-2003 (Copy enclosed),
the Government of Himachal Pradesh has also introduced Defined Benefit
Pension Scheme for new entrants, on or after 15-05-2003. The State shall follow
the new Defined Contribution Pension system for new entrants similar to
Government of India with suitable modifications as per the State requirement. The
State shall even wherever possible utilize the institutional frame work as created
by Government of India for managing pension fund like Pension Fund
Regulatory & Development Authority, Central Record Keeping & Accounting
infrastructure & Fund Managers etc.

Keeping in view the above facts, I am, therefore, to request
to kindly provide the copy of the detail scheme of "New Defined Contribution
Pension" system for new entrants, to this department at the earliest.

NOTIFICATION

In exercise of the Powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh is pleased to make the following rules further to amend the Central Civil Services (Pension) Rules, 1972 in their application to the State of Himachal Pradesh, namely:-

1. Short title and commencement:-
 1. (1) These Rules may be called the Central Civil Services (Pension) (Himachal Pradesh First Amendment) Rules, 2003.
 - (2) They shall come into force from the date of publication in the Rajpatra Himachal Pradesh.
2. Amendment of rule -2:-
 2. After clause (h) of rule-2 of the Central Civil Services (Pension) Rules 1972, the following new clause (i) shall be inserted, namely:-

"(i) All appointments made in the State Government of Himachal Pradesh on or after the date of publication of the notification in Rajpatra, Himachal Pradesh."
